The procedure for tendering shall be design built and operate. Under this type of procedure the contracting firm will be responsible for:-

- Condition analysis of the STP
- Check the design and suggest the modification as may be required.
- Execute the work been identified by the bidder.
- Provide the functional guarantee.
- Operate and maintain the STP for atleast 5 years.
