1. GRANT OF DEARNESS ALLOWANCE TO CANTT FUND EMPLOYEES

Reference CBR No. 44 dated 07.06.2019.

17. DELIMITATION OF CANTONMENT.

To consider the suggestion/objection received vide letter dated 28.11.2019 from Sh. Shalinder Khanna B.No. 105, regarding the delimitation of Cantonment boundary. The following objection was received.

- 1. वार्डों की सीमा निधारित करते समय ऐसा लगता है कि Census population के Block तोड़ दिए। क्योंकि सभी वार्डों में काफी कांट छाट की गई लगती है।

Accordingly, the letter was written to the Deputy Director, Directorate of Census Operations, Haryana for obtaining details of enumeration block of census. As per the documents already available and received, it was found that there were two enumeration block one in ward no. 2 (old) & one is ward No. 6 (old) which were broken and the old portion of ward no. 2 (Safaikaramchari qtrs. near GP lat no. 29) were shifted to ward No. 1 & B no. 149 & 150 earlier in ward no. 6 was shifted to ward No. 7 to maintain parity of voters after implementation of the order of Hon'ble Supreme Court.

Now as per the suggestion/objection, there is a requirement to change in the existing draft map accordingly. The safikaramchari qtrs. be shifted to ward No. 2 and B No. 149 &150 be shifted to ward No. 6. The area of P&T colony from ward No. 8 be shifted to ward No. 7 for the parity of civil votes in each ward.

This office has prepared/modified/changed the map and detail accordingly as mentioned above and ensure the parity of civil votes in each ward.

The Committee has further recommended that area of such toilet should not be more than 1.8 sqm and the width should not be less than 900 mm. The MoD, vide their ID no. 2(2)/2018-D(Q&C) dated 05.11.2019 have accordingly decided that the Cantonment Boards shall allow/permit construction of a w.c/toilet in existing buildings in absence of any such provision within the tenement to an authorized resident, subject to condition that proper sewerage connection to the said building already exists in the Cantonment. The report in this regards has been submitted to higher authorities vide Proforma No. 80. Dated 24.10.2019.
