#### 5. LEAVE APPLICATION OF MEMBER:

Reference CBR No.3 dated 16.08.2018.

Sh. Virender Kumar vide his letter dated 19.11.2018 had requested to allow some time for attending the Board meetings. In this connection, it is mentioned that he has not attended last seven meetings of the Board.

The matter needs consideration to take further necessary action with regard to the absence of Sh. Virender Kumar in the Board meetings.

#### RESOLUTION NO.5: Considered in detail. It was apprised to the Board that:-

i)Shri Virender Kumar, MCB had submitted an application on 11.7.2018 requesting for two months leave. This application was placed before the Board in its meeting dated 16.08.2018, wherein it was objected by the VP on the grounds that FIR has already been registered against Shri Virender Kumar on account of case under section 302/120-B IPC and section 25 of Arms Act. The VP informed the Board that the member is evading arrest. As per CBR No.03 dated 16.08.2018, a Show Cause Notice dated 21.08.2018 was served upon him stating that as to why the Cantonment Board may not take action against him for non-attending the meetings. Shri Virender Kumar vide letter dated 30.8.2018 stated that due to some legal matter he had not been able to attend the Board Meetings, as and when he will get out of legal matter, he will come to attend the Board Meetings and requested for some more time.

ii)A legal opinion dated 15.09.2018 has been sought from Shri Jitender Kumar Sharma, Advocate (CB Counsel), who on going through the FIR dated 06.05.2018, application dated 11.07.2018 of Shri Virender Kumar, CBR No.3 dated 16.08.2018 and Show Cause Notice dated 21.08.2018 and letter dated 30.08.2018 opined that the Member

Shri Virender Kumar explained his absence as per his letter dated 30.08.2018 and the criminal case under section 302/120-B IPC and section 25 of Arms Act is still under investigation, so no action for removal of Member Shri Virender Kumar can be taken against him at this stage.

iii)Shri Virender Kumar MCB vide letter dated 08.11.2018, received on 19.11.2018 in this office, again stated that due to legal matter he had not been able to attend the Board Meetings, he also stated that he will attend the same very soon and requested for some more time.

Sh. Surinder Kumar pointed out that sh. Virender Kumar has served for 25 years as VP/Member, hence, last opportunity by giving notice to attend the meeting be given to the concerned member. VP & other Members stated that ample opportunity has already been given to him and a copy of FIR was also submitted, the Board may send the case to remove the member to the higher authorities.

The Board took cognizance of continuous absence of Shri Virender Kumar from Board Meetings for 09 months (08 meetings). The reason of absence explained by Shri Virender Kumar in his applications dated 11.07.2018 and 30.08.2018 did not seem to be satisfactory. Hence the Board resolved to forward the case for removal of elected member Shri Virender Kumar as per section 34(1)b of Cantonments Act, 2006.

It is mentioned that this office has developed Recruitment portal inhouse i.e cantiboardrecruit.org to cater the recruitment of all cantonment boards in India.

We are dealing with the public data and recruitment of cantonment boards of India so migration of our portal is recommended to provide the security to public as well as to our Cantt Board for their recruitment process .
